### **NOVOMATIC further expands casino competencies in Lithuania**

### Gumpoldskirchen, 13 April 2015 (OTS) - NOVOMATIC, Europe's largest gaming technology group, further expands its competencies as a casino operator in Lithuania.

On 1 May 2015, NOVOMATIC'S local Lithuanian subsidiary operating under the trademark "Casino Tornado" will be opening in Kaunas what will be its fifth casino operation in Lithuania. The new location will increase the total number of gaming terminals operated by NOVOMATIC at its casinos and at 20 other gaming establishments across Lithuania to over 700.

In addition, after extensive and comprehensive negotiations, the Tornado team has successfully obtained another license for the operation of a casino in the capital city of Vilnius. This license award for what will be the sixth casino operation in Lithuania, impressively demonstrates the successful activities of NOVOMATIC's local Lithuanian management who will then be backed by over 600 employees. The casino is projected to open in the fourth quarter of this year.

NOVOMATIC has been very successfully engaged in business activities in the Baltic States for over 20 years. In Latvia, Estonia and Lithuania together NOVOMATIC employs a staff of over 2,000 and in addition to the five casinos in Lithuania, operates a total of 160 gaming establishments offering 4,600 gaming terminals.
